1. Historic Preservation Commission Meeting Minutes from November 2, 2021.

Commissioner Reckard asked for a number of edits to the draft minutes.

Commissioner Reckard requests that the draft stating "Commissioner Reckard stated he did not believe the Historic Preservation Commission had the authority to make decisions," be revised to read, "... authority to establish policies or make decisions for the Borough."

Commissioner Reckard requests that the draft stating "Commissioner Reckard does not feel the Historic Preservation Commission has powers to make decisions that affect the local government," be revised to read, "Commissioner Reckard does not feel the Historic Preservation Commission has authority to establish policies or make decisions for the

1. Reports and Communications to the Commission by Community Planning Staff

Melissa Kellner, Long Range Planner, noted that although she had received an update on Fort Greely cultural resources it is outside the commission’s purview. Ms. Kellner provided an update on the vacant commission seats and stated she will present information regarding the scope of the commission’s duties and powers once available.

Trish DeNardo Schmidt, Friends of S.S. Nenana, asked who would be responsible for demolishing the house and Vice-Chair Peirsol responded she did not know.

Commissioner Viltrakis spoke on her efforts setting up a local Girl Scout museum and the presentation she had given to local youths.

Vice-Chair Peirsol provided a status update on the Chena Building.

3. Report by Patricia Peirsol on the USAG Alaska Cultural Resources Working Group

Vice-Chair Peirsol updated the commission on points of discussion from the working group meeting.

NEW BUSINESS

1. Report on the S.S. Nenana Project at Pioneer Park by the Department of Public Works

David Bredlie, Public Works Director, introduced Jonathan Shambare, Design and Construction Manager; Leslie Gonzalez, Project Manager; and Marko Stepovich, Engineer. Mr. Stepovich provided a presentation on the S.S. Nenana Project at Pioneer Park.

Vice-Chair Peirsol praised the presentation and was pleased the construction project was underway.

Vice-Chair Peirsol asked what building code is being used for the reconstruction.

Mr. Stepovich stated the project was following the City of Fairbank's recommendations. Mr. Stepovich also stated the project is using the International Building Code and the International Existing Building Code. Mr. Stepovich also explained the reasoning behind emergency lighting.

Vice-Chair Peirsol asked about the City of Fairbank's building department's scope of involvement.

Mr. Stepovich provided the city's reasoning for what codes are currently being enforced.

Vice-Chair Peirsol wondered if there was any information that could be given to the commission regarding the building codes.

Mr. Shambare provided more information regarding the building codes and the challenges presented by the uniqueness of the building with a focus on safety.

Mr. Stepovich further elaborated on building code regulations.

Ms. DeNardo Schmidt stated there is a historical building code for boats and that has been distributed to the city.

Chair Proue and Vice-Chair Peirsol thanked the staff for their presentation.

2. Consideration and approval of a letter of support for the Phase II S.S. Nenana Project.

There was discussion on whether a letter of support would still be valuable to the Friends of the S.S. Nenana. The general agreement was that it would be.
